MANDATORY DISCLOSURE OF COMMERCIAL OFFICE BUILDING ENERGY EFFICIENCY

GTAS is positioned to support government legislation aimed at commercial property that is effective mid 2010. This legislation requires owners of buildings over 2,000m² NLA to disclose a Building Energy Efficiency Certificate (BEEC) to prospective buyers and lessees at the point of sale and lease of office space (>2000m²).

GTAS can compile and maintain a BEEC for you, leaving you to focus on your business.
